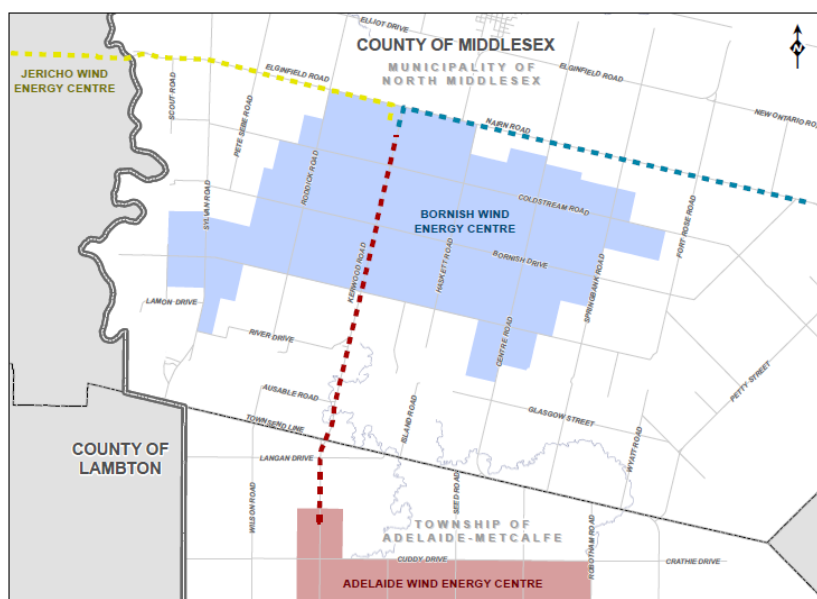

Dear Mayor and Members of Council:

The purpose of this letter is to provide County Council with background information in support of our delegation to Council on November 27, 2012 regarding NextEra Energy Canada's (NextEra Energy) wind energy projects in Middlesex County. These projects have been in the planning stages at the local municipal levels for upwards of five years. We have met on several occasions with County staff to discuss matters of interest to the County, namely impacts of our proposed project infrastructure within County roads. This letter is an update on our project planning status for NextEra Energy's following projects:

- Bornish Wind Energy Centre (73.5MW) – North Middlesex;
- Adelaide Wind Energy Centre (60MW) – wind energy centre located in Adelaide-Metcalf, but overhead transmission line and point of interconnection to Ontario transmission grid in North Middlesex;
- Jericho Wind Energy Centre – (150MW) – project located within Lambton County, but overhead transmission line and point of interconnection located in North Middlesex.

These projects all include proposed overhead transmission lines which are located on County Roads, namely Kerwood Road, Elginfield Road, and Nairn Road as shown on the key map below. These lines are proposed to be hung on separate single poles at an agreed upon location within the County right-of-way.

The projects all have proposed construction start timeframes beginning May 2013 to May 2014. As such, it is important that we continue discussions with the County in order to execute a Road User Agreement to the satisfaction of all parties involved.
